- Prizes are:
 - Adult Division (Male & Female) 1st Place \$1,000, 2nd Place \$250, 3rd Place \$100
 - Junior Division (Male & Female) 1st Place \$1,000, 2nd Place \$250, 3rd Place \$100
 - (Other Prizes Determined By The Liberty Opry)
- There will be no prize substitutions.
- Liberty Opry employees, contractors, family members, sponsors, and their partners and affiliates are ineligible.
- The Liberty Opry and contest producers have the final decision on all matters not covered in the above rules.
